# TERMS & CONDITIONS TO OUR TENDER ENQUIRY NO. REF: PPP/SD/039/2011 DT.15.12.2022 FOR SCRAP DISPOSAL

- 1. Category of items available as scrap at our factory to be segregated item wise by your personnel and to lift in "as is where is condition" on actual unit (Kgs/Nos/Tonns) basis as per our enclosure.
- 2. All statutory charges such as TCS, GST etc., as applicable at the time of lifting scrap will be charged extra on your accepted rates.
- 3. Offers should be forwarded exactly as per the list of scrap items enclosed.
- 4. The contractor shall arrange to lift the available scrap once in a week, or earlier, if required as per the guide lines from Environment Officer.
- 5. Scrap Disposal accumulated out of scrap should be removed from the scrap yard, once in a month on need basis, by the contractor, without any additional cost.
- 6. Quotations should be sent along with a crossed Demand Draft for Rs.25,000.00 (Rupees Twenty Five thousand only) as Earnest Money Deposit payable to M/s. Karnataka Antibiotics & Pharmaceuticals Limited, Bangalore.
- 7. Offers without the Earnest Money Deposit will be ignored without any further correspondence.
- 8. The EMD of successful tenderer (s) will be retained as security deposit till the completion of the contract.
- 9. The EMD of such of the unsuccessful tenders will be returned without interest within 30 days of finalisation of the contract.
- 10. Valid Certificate / Permission from Karnataka State Pollution Control Board / Central State Pollution Control Board (KSPCB & CSPCB) IS MANDATORY. (Plastic Waste obtain from KSPCB)
- 11. Quoted rates, if accepted, shall be kept valid for a period of three years from the date of finalisation of the contract, or may be extended further, on mutual consent as per discretion of Management.
- 12. For operational reasons, we prefer to award the contract of all scrap items to a single party. Therefore, tenderers are requested to quote for all the 45 items, listed in the enclosure. Failing which, offers are likely to ignored.
- 13. If the performance is not satisfactory, the management have to right to cancel / short close the contract.

- 14. The Management reserves the right to accept or reject any quotation, in full or part without assigning any reasons.
- 15. Preference will be given to Pharmaceutical scrap handling experienced contractors.

  The contractor has to allow minimum manpower trained persons at site for handle the shredding machine also.
- 16. Payment to be made in advance before lifting the scrap items.
- 17. Rejected printed cartons, labels, strips, Glass Ampoules & Vials should not be lifted from the Scrap yard. If these items are found during segregation, the same are to be destroyed in the presence of authorised E&P Stores/ Security Personnel.
- 18. Sealed vials and Ampoules, if found, on segregation of scrap are to be kept separately. No such items are to be lifted by you (Scrap Vendor) under any circumstances.
- 19. Weighments of empty vehicle and subsequent weighment of scrap loaded vehicle should be done in the presence of our authorized E&P Stores/Security representative.
- 20. The concept of QMS and EMS to be followed as per the guide lines from Environment Officer to be followed SAFETY / ENVIRONMENTAL ASCEPTS to be followed.
- 21. Production Scrap / Engineering Scrap deposited at scrap storage bins (Situated near scrap yard) are to be cleared at your (scrap Vendor) own cost, regularly.
- 22. Garden waste consists of Grass, Dried leaves, Tree Cutting branches, deposited near E.T. Plant to be cleared at Rs.2,000.00 per load, inclusive of labour, Transportation and other incidental charge if any.
- 23. If the performance is not satisfactory, the management reserves the right to cancel / short close the contract.

#### ANNEXURE – II

#### **ENVIRONMENTAL & SAFETY NORMS**

### ENVIRONMENTAL GUIDE LINES

- 1) All the workers' health check-up get it done and the certificate to be produced to the environment officer.
- 2) While handling the used solvent drums and bulk aluminium canisters properly segregated and clean properly separate Hazardous / Non-Hazardous.
- 3) During the handling of hazardous waste chemicals properly handled.
- 4) While loading of hazardous waste and non-hazardous waste properly segregated in the production waste yard.
- 5) Maintain the legal compliance documents properly like FORM, 8, FORM 9, FORM 10 is there any guide lines changes in the KARNATAKA POLLUTION CONTROL BOARD (KSPCB) to be incorporated immediately.
- 6) All the scrap lifting vehicles should have proper documents like vehicles emission test certificate.
- 7) Maintain identified at Production waste yard: GLASS WASTE, POWDER WASTE, ALUMINUM CANSTIERS with lock and key.

## **SAFETY GUIDE LINES:**

- 1) Use proper personnel protective equipment's (PPE's) MASK, HELEMET, FULL LENGTH OF HAND GLOVES, GOGGLES).
- 2) While loading / unloading of the hazardous waste materials inform to concerned departments in charges.
- 3) While cleaning of containers like MS DRUMS, BULK CANSTIERS, BARRELS handled properly. (Separate properly hazardous / non-hazardous drums, barrels etc.)
- 4) Maintain properly production waste yard to avoid fire, falling of the drums etc.,
- 5) Trolley movement properly handled.
- 6) Vehicles Driver's license and proper documents and should obtain the permit from the concerned department Head / Environment officer.
