3. KAPL is not responsible for postal / courier delay. Personal delivery is accepted. Late and incomplete submission of bids will be rejected. The language of bids will be only in English.
4. KAPL reserve the right to accept or reject of any offer and the decision of KAPL is final. All disputes arising out of this Tender/order/contract shall be referred to the MD, KAPL only.

Other Terms:

1. Rates for Full Truck Load and Part Load to be mentioned separately with all related terms & conditions clearly.
2. Loading, Unloading Charges, Door Collection & Door Delivery Charges, Statistical Charges, Minimum Chargeable weight etc. should be mentioned separately.
3. Our Materials are covered under transit insurance; hence no extra cost is acceptable. In case of loss in transit (shortages / damages) necessary certificate to be issued by the transporter for the purpose of Insurance Claim within 15 days on receipts of communication of concerned branch.
4. In case of damage /short delivery up to the value of Rs.6,000/- it will be deducted from your bills, whereas in case of damage/short delivery above Rs. 6,000/- insurance claim with all relevant documents to be produced within 15 day from the date of delivery at the destination level to claim the amount from our underwriters. Any mix up of consignments between destinations is the responsibility of the transporter to rectify the mistakes, if any.
5. Applicable GST should be indicated separately.
6. Payment will be released within 45 days from the date of submission of bills along with the original acknowledged L.R. Copies Or POD's (along with shipping bills for Nepal consignments).
7. Quoted rate would be valid for two year from the date of Agreement to be executed with the approved transporters and extendable to another one year.

- On appointment, party shall provide interest free security deposit of Rs.50, 000.00 to the company.


Offers shall be valid for 120 days from the date of Opening of the bids.
