19. **Risk Purchase Clause:** If the services are not maintained and due to that account KAPL is forced to obtain the services at your risk and cost from elsewhere after due notice to you, the loss or damage that may be sustained there by will be recovered from the defaulting service provider.
20. **Payment terms:** Monthly 100% (Hundred Percent) within 30 (Thirty) days on receipt and acceptance of the bill invoice as per work order at destination and on production of all necessary documents.

Unless otherwise directed by KAPL in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.
