19. **Risk Purchase Clause:** If the work is not completed and maintained and due to that account KAPL is forced to execute the work at your risk and cost from elsewhere after due notice to you, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.

## **ANNEXURE -A**
