18. **Risk Purchase Clause:** If the test reports submitted as per the agreed schedule are not and due to that account KAPL is forced to go for testing with other vendor, at your risk and cost from elsewhere after due notice to you, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.
